- 1) The benefits of the Trust/institution shall be open to all irrespective of caste, colour, creed or religion.
5. Sh. Sanjay Dhand is hereby nominated as Chairman of the Trust Sh. Yodha Kumar is nominated as President and SHL Aman is nominated as Secretary of the Trust.
6. The Trustee shall hold the office for life until they resign therefrom.
7. Rules may be framed for the proper administration of the Trust, rules of the Trust at any time be altered, modified or amended and be notified for information of the persons connected with the affairs of the Trust. No amendment or alteration shall be made which may prove to be repugnant to the provisions of section 2 (15), 11, 12 and 13 and 80-G of Income Tax Act 1961 as amended from time to time and without prior approval of Commissioner of Income Tax.
8. Trust may open its or its Institutions account in any bank, post office or in any other financial institutions. The said accounts shall be maintained in the name of the Trust in the name of institutions operated by the Trust and such account shall be operated by such persons as authorised by the Board of Trustees from time to time.
9. Entire income of the Trust shall be utilized towards the promotion of aims and objectives of the Trust and shall be invested in the modes specified under the provisions of Section 13 (1) (d) read with Section 11 (5) of Income Tax Act 1961 and as amended from time to time.

Whereas the Settlor is desirous of and has decided to create an Educational Trust and has decided to settle irrecoverably, a sum of Rs. 11,000/- in cash for this purpose in the manner hereinafter provided.

Whereas it is desire of Trustee that corpus of Trust may be further increased from time to time by flow of funds and other assets including moveable and immoveable and any other kind by way of gifts, donation, acquisitions, allotments, grants exchange or other wise etc.

a) Rs. 11,000/- handed over in cash to the Trustee.

NOW THIS DEED WITNESSETH THAT FOR EFFECUATING THE TRUST

1. The name of the Trust shall be **SHRI KRISHNA EDUCATIONAL TRUST**.
2. The Trustees shall hold and stand possessed of the Trust property received for the Trust upon Trust to be used for such Public, Educational, Social & other purpose directly to the benefit of general public in any part of the Country.
3. The Head Office of the Trust will be Situated at W.no. 12, Yash Painter Street, Back Side Hind Hospital, Ahmedgarh or at any other Place or places as the Trustee may decide from time to time.
4. The Objective of the Trust are as under :-
 - a) To establish, open, run or manage schools or colleges where General, Scientific, Commercial, Engineering, Sports or any other type of Educaion be imparted to students.

16. Without prejudice to above provision any Trustee/member who works whole time in the Trust may be paid such remuneration as may be fixed from time to time by Board of Trustee or reasonable and proper interest on money lent or rent on premises let to the Trust by any Trustee.
17. All decisions of the Trust shall be taken unanimously. There shall not be any casting vote to any member of the Trust.
18. The management and administration of the Trust shall vest in the Board and the Board of Trustee may delegate the Powers to any member or to any other person for proper conduct or management of the affairs of Trust or any of its institutions.
19. The Board of Trustee have also power to appoint any member or members of Trust.
20. In the event of dissolution of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among members of the managing committee/ Trustee but same shall be transferred to the another Charitable Trust/Society whose objects are similar to those of this Trust and which enjoys recognition under Section 80-G of the Income Tax 1961 as amended from time to time.
21. The Trust formed shall be Irrevocable.
22. If any clause herein above contained, contravenes any of the provision of the Income Tax Act or Rules or amendments made therein from time to time, granting exemption of the Income/Registration, then such clause (s) shall be deemed to be redundant from the date of its contravention.

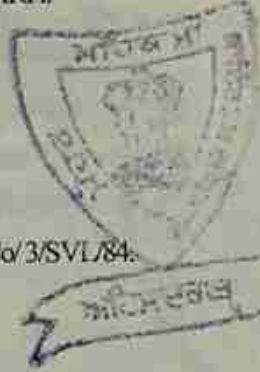
